#### THE DEMAND FOR TRANSFER PRICING SPECIALISTS

As an indicator of market demand for graduates from a transfer pricing module/certificate program, I looked at several job search websites on November 3, 2006. I checked for full-time positions in the United States, either listed over the past 30 days or currently available. On one search engine (CareerBuilder), I could identify primary subgroups within a category; these are shown with an asterisk.

Note that total openings will be inflated by doublecounting if jobs are listed on more than one internet job search engine, and should therefore probably be ignored. The most conservative measure is the maximum number listed on any of the sites (that is, the highest number listed on any of the sites). Also relevant is the average number listed across all the sites (that is, the sum of the listings on all sites divided by the number of sites). These two numbers are calculated and then the jobs are ranked according to each measure.

### The key results are that:

- <u>International Taxation is ranked as #1</u> in terms of the maximum and average number of fulltime job openings in the United States over the past 30 days. <u>Approximately one-third of these openings involve transfer pricing.</u>
- <u>Transfer pricing is ranked second</u> in terms of the maximum and average number of fulltime US job openings over the past 30 days.
- There are more job openings in transfer pricing than in international accounting (396 vs. 374).
- There are more job openings in transfer pricing than in the next six job categories (after International Accounting) added together (i.e., there are more job openings in Transfer Pricing than in International Marketing, International Trade, International Development, International Management, International Finance and International Economics all added together 396 vs. 375 openings (maximum listings)).
- Since transfer pricing is a much narrower specialization than many of the other terms I searched, the large number of openings is an indication of the strength of demand for these individuals. As noted above, for example, about one-third of international tax professionals have transfer pricing as one of their job functions.
- It is clear that openings for transfer pricing professionals are very strong. While the listings include both graduates and individuals with significant work experience, the demand for graduates from a transfer pricing module/concentration is highly promising. The best prepared students will be those who have also taken courses in finance, accounting and tax and, of course, my International Transfer Pricing and Multinational Enterprises courses! #### AOL Search with Career Builder (http://aol.careerbuilder.com)

• Search: Fulltime positions within the United States listed over the past 30 days. Career Builder allows you to look under a main heading (e.g., "transfer pricing") and then break the number of openings down by subheadings (e.g., "tax" or "finance"). The subcolumn, "\*TP & Consulting", for example, shows the number of fulltime openings over the past 30 days listed as Transfer Pricing (main field) with Consulting (subfield); that is, there were 396 fulltime positions listed in transfer pricing over the past 30 days and of these 24 were consulting.

• Search for full-time jobs posted over the last 30 days.
